John Kennedy Senior ("Kanga") was the Patron of the HFCPPOA.

A Patron is someone of high standing who supports and endorses the cause(s) of an institution or association. Kanga was a fantastic choice as our Patron because he embodied and encouraged so much of what the HFCPPOA seeks to represent and achieve. His "executive" capacity at the Club involved playing and coaching. He wasn't the greatest player, by his own admission, notwithstanding 164 games and 4 Club best and fairest awards. But, he was a great teammate; always participating and encouraging. When the going got tough you wanted to have Kanga nearby. He loved training hard and playing hard. He loved doing all those things with his teammates. He did not think you could enjoy team success in sport without having teammates who would "die for the jumper".

In Kanga's world you could be effective as a teammate by following the rules of the team and playing your part, even if that part was not the most celebrated or glamorous. You could be effective without a lot of finesse; just getting the job (or your job) done was what mattered.

As a coach, he liked action, not words. He liked spirit. He discounted glamour. He liked team rules but he didn't stymie flair and personality.

He loved that his Club, the Hawks, involved so many people with different interests and contributions - teammates, leaders, administrators, volunteers, supporters - united by a passion to contribute to and support a sporting team in a unique, competitive, indigenous sport, whose colors were brown and gold.

He believed that a sporting club is much stronger if there is a forum for its traditions and values to be passed on over successive generations. And for those who have had an involvement with the Club to continue to be afforded an opportunity to remain associated with the Club, and be part of the Club's fortunes - good and not so good - even if their own "executive" time at the Club had ceased. He believed the Club needs to look after its valued participants; there should be support when need arises; there should be gatherings to enable the perpetuation of stories and traditions so the foundations remain strong. This should all be done in a convivial environment. It is these values and aspirations that underpin how the HFCPPOA seeks to conduct its activities and what the HFCPPOA seeks to provide for its members.

So to "Patron Kanga" we say thanks for your guidance and support. Your legacy is huge, and lives large.
